HEARING AID DISPENSING CE COURSE

About the program: Any individual who is engaged in the act of **Fitting, Selecting, Renting, Adjusting, or Servicing** of hearing aids or **Any Other** instruments to compensate for impaired hearing." This includes **Cochlear Implants** as well.

The Department of State: Division of Licensing requires that the following three segments: NYS and Federal Rules and Regulations, Infection Control and the newly mandated Hearing Assistance technology (HAT) and T-Coils (January 1, 2019) are required to be taken once every two years.


